The Sport and Culture Group is a collaborative group of scholars based in the School of Sport and Exercise Science at Victoria University (VU).

The unifying aim of the Group is to advance critical understanding of sport through individual and collaborative research and writing projects that explore the role of sport in local and global communities.

The work of Group members is multi- and cross-disciplinary, and is based on core disciplines of economics, history, philosophy, management, and sociology. These disciplines not only drive the operation of many of the School's research projects but they underpin areas of postgraduate supervision.

All members of the Sport and Culture Group are associates of the Institute for Sport, Exercise and Active Living.

The Sport and Culture Group has a clearly defined but flexible organisational structure. Its core membership consists of full time staff within the School of Sport and Exercise Science at VU.

It also provides for both associate membership, which includes graduate research students, sessional staff and alumni with links to the School, and affiliate membership, which is open to selected external partners.

All staff, associates and affiliates are actively connected to one or more of the eight specialist research units listed on the right. These units are responsible for coordinating student research activity, promoting staff research projects, and managing industry partnerships and consulting initiatives.

sport and physical activity participation.


